These are just two of the benefits Farm*A*Syst has to offer you. Assessments provide suggestions for protecting your drinking water and make financial and technical resources available to help you take action.

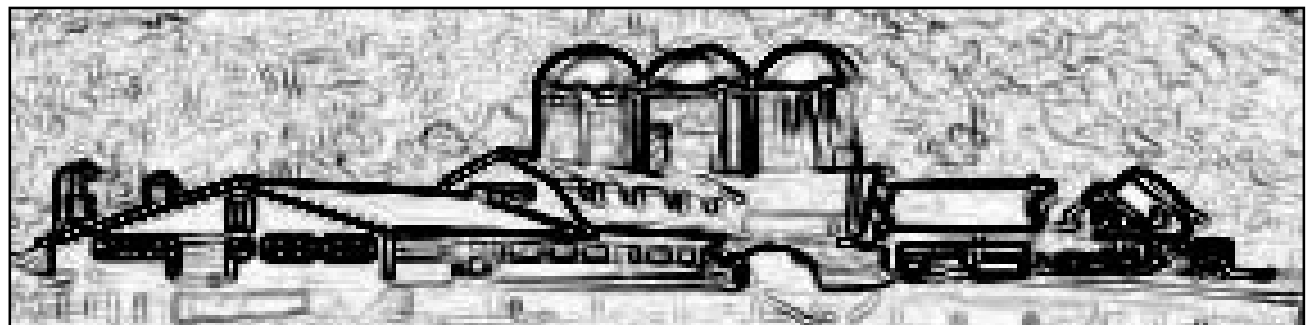
Two national awards, the Renew America Award and the Honor Award from USDA, have recognized Farm*A*Syst as a valuable tool for the farm community.

This program is free and voluntary. In the tradition of Conservation Districts, we are working with the farm community to help you do what you are already doing: conserving our resources for the generations to come and protecting the health of your families.

- Build an awareness of how your activities can pose risks to your drinking water.
- Build public awareness of how your farm conserves our natural resources.
- Identify sources of financial, technical and educational resources available to help you take voluntary action.
- Develop individual, voluntary action plans to protect your family's drinking water.
- Empower you and your community to protect private drinking water sources without cumbersome regulations.
- Provide you with free water testing beyond what the milk coops offer.

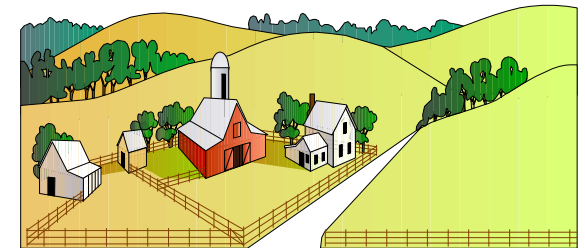
